A-8-Nathaniel Holcomb, p. 10, Farmer, Simsbury, Hartford Co., Conn. was a tax payer in Windsor, Hartford Co., Conn. 1675; moved to and became a 1st settler in Granby, Hartford Co., Conn. in 1677; chosen Deputy to the General Court of Conn. for Simsbury for 6 terms, 1703-1706 and 1720-22; was a joint signer June 27, 1687 of an agreement with pastor of church of Hop Meadow, signed Feb. 4, 1688 an offer to citizens of Salmonbrook and Low Meadow for exchange of parts of land " to better fortify against Indians "; as " Nathaniel Holcomb Sr. " signed will Feb. 7, 1740/1, bequeathing to wife (not named) ; to " sons, Nathaniel, Johnathan, John and Benjamin " and to " my 5 daughters, Mary, Katherine, Hester ( Esther ? ), Sarah and Margaret " and to " the son of my daughter, Martha, deceased to buy Bible " and named " son, Benjamin " executor ; m. Springfield, Mass. Feb. 27, 1670 Mary BLISS, b. Sept. 23, 1651, d. 1741, dau. of Nathaniel of Springfield, d. England, d. 1650, m. 1646 Catherine CHAPIN, who d. 1712, dau. of Samuel of Springfield, one of the original proprietors of Hartford, Conn. A-8-1-Nathaniel Holcomb II served as Lt. in 1716, lived Simsbury, Hartford Co., Conn. which he represented in the General Court of Conn. for 4 terms, 1748-53; m. Nov. 1, 1695 Simsbury to Martha BUELL, b. Springfield, Mass., Dec. 27, 1675, dau. of Peter and Martha ( COGGAN ), he of Windsor, Conn., she, of Boston, Mass., son of William, immigrant from Wales in 1635. Martha was grand dau. of William BUELL, original land owner of Windsor. Ch. ( b. Simsbury ) 1 and 2-Nathaniel III and David, ( twins ) , Oct. 25, 1696. As " Thankful Holcomb " she signed in 1734 with other heirs of her father, George HAYES, deed to part of land of his estate to her half-brother, Daniel HAYES, A-Ch. Roger Enos' Regt., received July 1781 for bounty paid by town of Granville; also served as private in Capt. Ja-phet DANIEL'S Co., Lt.-Col. Calvin SMITH'S ( 6th. ) Regt., paid from July 9 to Dec. 31, 1781; order for payment signed Aug. 11, 1783, for " year 1781 in the late 6th Mass. Regt. "; was member of Church of England; m. 1st Hannah HOLCOMB, b. Jan. 19, 1739, d. May 1780 " whose parents were Presbyterians ". Ch. ( b.
