The Holcomb Branch of James⁷ (Levi⁶, Ezra⁵, David⁴, Nathaniel^{3, 2}, Thomas¹)

Originally this article was going to focus on just finding the parents of my male ancestor James⁷ Holcomb, the spouse of Olive⁶ Noble (Joel⁵, Mark⁴, Noah³, Mark², Thomas¹), of Washington County in northern New York. But it soon became apparent that starting with James'⁷ grandfather Ezra⁵, and detailing the collateral lines within each direct family unit, would be more helpful to understanding the dynamics of this branch of Holcombs.

What Has Been Printed

The earliest mention of James⁷ by a researcher was in Mr. Lucius Boltwood's book^[1] regarding the descendants of Thomas Noble. Mr. Boltwood collected his information during the 1850s and printed his material in 1878. He had first hand knowledge of James⁷ and Olive's marriage, family structure, along with her parentage, birth, and death, yet offered few details about James⁷ other than he was of Granville, Washington County, NY.

In her 1988 book, "Thomas Holcomb and other Simsbury, Connecticut Families", Ms. Deanna Holcomb Bowman attempted to link^[2] James⁷ as the son of James⁵ (Consider⁴, Thomas³, Joshua², Thomas¹), a branch of Holcombs that does not contain a single use of the name Levi till one of James⁵ first cousins in Pennsylvania named a son Levi. Neglected by most who laid claim to her tie-in was the question mark at the start of her entry. Her proofs were limited to name association and the common location of New York state. The 1790 census^[3] for James⁵ was from Kinderhook, NY, one hundred miles south of Granville, NY, which leads us to the conclusion that he was at that time over forty-five years of age, married, and had two older males who were teens and/or early twenties in his household. Other sources, without proofs, add that James⁵ was married to Ester Ganyard, a descendant of Adam "the mulatto" Rogers (more about this in the DNA section below), and was the James Holcomb who moved to Ohio around 1802 where he died after 1807.^[4]

Using the above scenario, James⁷ would have been about ten years old at the time of the move from New York to Ohio, but nine years later he ended up much further north in New York married to a local girl of standing, and remained there the rest of his life. The more logical story is that James⁷ began and ended in northern New York, and married the girl next door.

The standard on the pedigree of Levi⁶ comes from the last page of Mr. George E. McCracken's 1981 TAG article^[5], "Thomas Holcombe's Earlier Posterity", where he listed Levi⁶ as both the third child and son of Ezra Holcomb and Phebe Gillette. Mr. McCracken's material relied upon the records that were originally gathered by Rev. Amasa Holcomb in the mid 1800s, and perpetuated by Dr. William Frederick Holcomb through the early 1900s. Ms. Bowman developed Levi⁶ a little further by listing his children^[6], but without details. The most recent information comes from Ms. Carol Laun of the Salmon Brook Historical Society who wrote"Levi⁶ Holcomb" ^[7] and "Ezra⁵ Holcomb" ^[8], that she updated in 2014 after I contacted her in regards to James⁷.

[1] My 8th great-grandfather, Rev. **HENRY WYCHE**, Rector of Sutton Church at Surrey, England, was the son of Gentleman **RICHARD WYCHE** (a founding member of the East India Company), and the grandson of Sir **RICHARD SALTONSTALL**, Knt., the Lord Mayor of the City of London (the Crown). RICHARD WYCHE was granted, and to <u>all</u> his descendants forever, the Crest of the Wyche Dexter Arms on August 15, 1590. The Wyche motto is "Malgre le Tort", which means "despite the harm", and when combined with the crest, promotes the Mosaic Law of allowing your opponent to make right the damages they have caused you before deciding your next course of action. Saltonstall's nephew (my first cousin), another Sir **RICHARD SALTONSTALL**, was one of the twelve grantees of the Massachusetts Bay Company. Confirmed via my membership with the Order of the Crown of Charlemagne (no. 2685).



Next is a pedigree summary of the above printed pedigrees, with supplemental details from original records, and speculations using logic to create the most likely information, beginning with the family of Ezra⁵ and continuing through James'⁷ family. Bracketed information is not to be relied upon, but is supplied to help future researchers. After the summary, the focus shifts to the details, records and interactions of the Holcombs at Washington County, NY.

Pedigree Summary

The 1801 will of EZRA's⁵ son Enos was the key to identifying the family members listed below. Enos gifted 62 cents 5 mills each (must have been the same as leaving a \$1.00 to someone today) to Silas, Levi, Alvan, and Chloe, then divided his land and structures to his siblings as follows: 1/4 to Ezra, 1/4 to Jesse, 1/4 to Asa, 1/8 to Phebe, and 1/8 to Asenath. Enos' ordering of the names might imply that Silas was older than Levi as the other names are ordered by age, with the women following the men in their own similar order.

LEVI was only one of sixty men who were listed as a top tier Elector (could vote for Senators, Representative, and local positions) for Washington co., NY in 1795 due to his standing and value of owned land (research "White Suffrage Movement" from the late 1820s and early 1830s for significance).

Possible son Levi (vii. below) and probably children William or Asa (viii. below), and/or Levi B. (ix. below) were by LEVI's⁶ second wife CHLOE PISON who he married in 1798. On the 1810 census an older female with two teenage females are listed that do not fit into the family's prior census information; one of the teenage females could be Hulda (______) Clark (vii. below) who shows up in censuses as born 1796, NY married to Benjamin Clark. Note to future researchers: the journal records of Dr. Liberty Branch from the early 1800s at Fort Ann supposedly has two entries for services provided LEVI⁶ that may list family members.

Before the 1840 census Levi⁶ had moved to Pennsylvania and returned, living closer to him so that in the 1840 census for Jasper, NY both are on the same page with the same families surrounding LEVI B. as before. By 1850 both are at Dodge co., WI, him at Herman, WI and Levi⁶ seventeen miles away at Burnett, WI.

James⁷ was a carpenter and joiner. He must have been a smart businessman, as he owned quite a bit of property, including a slate operation and a blacksmith shop at Granville/Whitehall.



His second wife was on several land deeds with him and she brought a daughter Ellen (or Helen), b. abt. 1849, NY, into the marriage. Children Mary Ann (xii. below) and James H. (xiii. below) are from this second marriage.

James⁷ had children over a period of 48 years. He did not have a probate file, but his lunacy hearing shortly before his death does list his children and was probably the method that his estate was settled. The last two children were minors when he and his second wife died, but there are not any records of a guardianship case.

His name is listed as "Levi S." on the 1880 census and on their daughter Lucy's marriage record to Stephen Chaffee. The death record for their son Lewis Fowler Holcomb, who was possibly named after his uncle of the same name (who was ordained a LDS priest in 1866), listed his mother's name as Susanna Jane Wiley born in Gloversville, NY. Neither LEVI⁸ nor SUSANNA had probate records. It is possible that Wiley is actually Wyllys.

Children of Olive Cordelia Holcomb, by Russell:

- a. MARY RUSSELL, b. 1841, NY. Listed in the household of her grandfather James Hocum (Holcomb) in 1850 and 1855; the 1855 Census also lists her mother (O. C.) and stepfather Jillett. In the 1855 census Mary is listed as the 14-year-old wife of the 64-year-old James. It is possible the census worker combined the information about James' new wife Mary Ann, b. IRE, with Mary Russell together.
- b. Poss. WILLIAM [Russell], b. 1843.
- c. Poss. **JAMES** [Russell], b. 1845. These last two children may have died early, or belonged to other parents.

DNA Testing

My next move was to have DNA tests performed by both my father¹³ and myself¹⁴, which definitively proved our male descent from Thomas¹. Shortly thereafter my father's paternal aunt¹² completed a DNA test and her genetics were listed as one hundred (100) percent white, eliminating the above Ester Ganyard as a possible ancestor.

While waiting for the DNA test results the legal records of Washington County, NY were searched to find as much information about the Holcombs as possible.

1790 to 1793 - Census and Land Records

The 1790 census listed Levi⁶ as the head of the only Holcomb family for all of Washington County, NY, which included four females who are assumed to be his first wife and three daughters.

A land record^[12] from 1790 documents Levi⁶ as a resident of Kingsbury, NY^[see 18 below], purchasing 42 acres in lot 9 at Westfield (now Fort Ann), NY. The deed also mentions that a Henry Lewis owned the property next door.

In 1793 a deed^[13] was recorded at Hebron, NY by Levi's⁶ second cousin Noah⁵ Holcomb (John⁴, John³, Nathaniel², Thomas¹). Noah's⁵ family is well documented and does not include James⁷. Noah's⁵ deed was the last Holcomb land deed filed in Washington County, NY for forty-five (45) years outside of Levi's⁶ immediate family till 1838 when Horace A.⁸ Holcomb (Diodorus⁷, Abner⁶, Azariah⁴, Jonathan³, Nathaniel², Thomas¹) purchased land^[14] at Whitehall, NY.

During this time period, Levi's⁶ family increased with a daughter and two sons, Ezra⁷ and James⁷.

1796 to 1798 - Levi's⁶ First Wife Though Land Records

In regards to Levi's⁶ first wife we have three land deeds that give us a clue as to who she might have been. The first was a deed^[15] from 1796 that listed John Wallace of Pawlet, Rutland County, VT, as having purchased 200 acres in lot 9 at Westfield, NY, less amounts already conveyed to Levi⁶ and Henry Lewis. Then in 1798, two deeds^[16, 17] have John Wallace selling both Levi⁶ and Henry Lewis three (3) acres each for \$1 next to their existing properties [note for any researchers: Aaron Wright, Jr. was a witness to both deeds]. What is significant is that according to the 1795 Elector records for Washington County, NY, both Levi⁶ and Henry Lewis were listed as two of the top-tier electors (see Levi's⁶ citations above) out of sixty total, and John Wallace was part of a lower tier. All the early land records I have viewed involving nominal monetary amounts are between close family members.

1800 to 1811 - Census Records and Holcomb Noble Marriage

In 1800, Levi⁶ is again the only Holcomb family in the censuses of Washington County, NY, which now listed three additional young males in his household.

By 1810, the census records have Asa⁶ and Jesse⁶ joining their brother Levi⁶ at Fort Ann (was Westfield), NY. Both brothers would have been too young to be James'⁷ father. In the same census Levi's⁶ record adds another two young males, for five sons total, and one of the older males, possibly either Ezra⁷ or James⁷, drops off. It is possible that an eighteen year-old James⁷ was working fourteen (14) miles away in Granville, NY and would have been included in someone else's census entry, because just one year (1811) later he married Olive Noble. The



Nobles^[18] were a well-established family in northern New York and a marriage with another well-established family would fit the customs of the day.

[18] The 1762 Kingsbury, New York patent included Olive's father Joel's second cousin Gideon⁴ Noble (Stephen³, John², Thomas¹) and another cousin Thomas Noble. Levi⁶ listed his residence as Kingsbury on his 1790 deed above.

1813 - The Use of the Name Levi

About 1813 Levi⁸ was the first child born to James⁷ and Olive. What is significant is the male naming patterns found with Ezra⁵ and Levi's⁶ families, and the fact that James⁷ seemed to follow the same customs. Also significant is that Levi⁸ did the same with his first two sons Levi⁹ and James⁹. The unidentified second son of James⁷ could have been a James who died young. This may explain why James⁷ waited till he was about seventy (70) years of age to use the name again.

Researching the use of the name Levi in the Holcomb family found that the name first showed up in the fifth generation to two first cousins of Levi⁶, whose families stayed in Connecticut. The sixth generation netted two more two first cousins who also stayed in Connecticut; a fourth cousin who went to Pennsylvania; and of course Levi⁶ in New York. Generation seven netted the son of the one who went to Pennsylvania; and a third cousin in Ohio. Accordingly, each generation in my direct line, down to my brother¹⁴, has made use of the name Levi.

1815 to 1820 - Levi's Census and Land Records, with Family Connections

In 1815 at Fort Ann, NY Levi⁶ witnessed John Degolyer's will, which does not mean he was living there, but probably traveling back-and-forth to the property he had purchased at Chenango County, NY (180 miles east) in 1802 from Stephen⁵ Steere, Esq. and his wife Rispah Smith (see Levi's⁶ citations above). Stephen⁵ Steere was a second cousin^[19] to Caleb⁵ Steere who married Anne⁵ Leach. Further research finds that Caleb's grandson is the same Oliver⁷ Leach Steere who married Lucy Noble, sister of Olive Noble, the <u>first</u> wife of James⁷. And as per the 1870 census at Dresden, Washington co., NY, this same Oliver⁷ Steere and his wife Lucy are the ones who took in James⁸, son of Mary Anna Corbet, the <u>second</u> wife of James⁷, after they died in 1869 and 1870, respectively.

Before finding the Steere relationship I had assumed that Lucy Noble had taken in James⁸ because of her relationship with her former brother-in-law James⁷, which may still be the reason, but now an existing Holcomb - Steere relationship had already been developed from a generation earlier.

The 1820 census at Chenango County, NY revealed a Holcomb - Leach relationship through an Alex⁵ Leach that was living just a few houses away from Levi⁶. Alex⁵ was a second cousin^[20] of the aforementioned Anne⁵ Leach, the wife of Caleb⁵ Steere, which demonstrates another family connection.



Here is a diagram of these relationships:

To sum up the above information and diagram, focus on Oliver⁷ Leach Steere and Lucy Noble. His grandfather was a second cousin to Stephen⁵ Steere who sold the property to Levi⁶; his grandmother was a second cousin to Alex⁵ Leach who was 180 miles east of James'⁷ family, but lived just down the street from Levi⁶; and Lucy Noble was James'⁷ former sister-in-law who became James'⁸ guardian after James⁷ died.

1820 to 1840 - Washington County, NY Censuses

James'⁷ first census record in 1820 at Granville, NY listed him next door to his father-in-law Joel Noble. His family structure was shown as himself, a female the age of Olive, and three males under the age of ten. Other Washington County, NY censuses found Ezra⁷, Asa⁶, and Jesse⁶ Holcomb at Fort Ann, NY, and a Pheobe **Hocumb** at Hartford, NY just 11 miles from Granville, NY.

The Phebe / Pheobes listed in the pedigree summary above were to have been deceased by 1820. This Pheobe's census listed her as over the age of 45, a female in the 16 to 26 range (daughter?), and two children under the age of ten (children and/or grandchildren?). Either Pheobe's husband was away during the census, or she was widowed. If the members of her household were a daughter and grandchildren, then she was possibly just old enough to be James' mother, but it is more likely she was an aunt or sister-in-law. If she were James' mother and a widow, the customs of the day would possibly dictate her living with him or Ezra (see next paragraph for an example). No further records could be found concerning Pheobe.

The 1830 census for Granville, NY again listed James⁷ next door to Joel Noble with a female Olive's age and eight children in his household. Asa⁶ is the only other Holcomb in Washington County, NY at this time. The census in 1840 for James⁷ is similar, but by this time Joel had died and the older woman listed in James'⁷ record would be Joel's second wife.

1820 to 1837 Washington County, NY Land Records

In 1820 Ezra⁷ borrowed just over \$540 on Levi's⁶ property in lot $9^{[21]}$; and in 1822 and 1824, Ezra⁷ and his wife Matilda sold 54 acres of Levi's⁶ in lot 9 for \$960, and 54 acres in lot 10 for \$400^[22].

In 1825 James⁷ made his first recorded land purchase^[23] for 160 acres in lot 11 at Dresden for \$325.

If Ezra⁷ and James⁷ were partners in their father Levi's⁶ property the math would work like this: \$960 plus \$400 equals \$1,360 received from the land sale, subtracting the \$540 in mortgages and any interest and costs, they would receive about \$400 each. The \$540 in mortgages might have been their way of buying out Levi⁶. This is simply speculation, but the timing of James'⁷ first land purchase right after the first recorded Holcomb land sale in Washington County, NY in almost thirty (30) years does raise the possibility.

The balance of land records show Ezra⁷ and Asa⁶ selling and James⁷ buying land to increase the size of his farm and other operations.

By 1837 James' is the head of the only Holcomb family with recorded land ownership at Washington County, NY, till 1838 when Horace A. Holcomb purchased land in Whitehall, NY.

Other Family Ties

The pedigree summary lists Levi's⁶ mother and aunt as Gillettes, three of James'⁷ children married Gillettes, and Olive Noble's sister Naomi married Jonathan Gillette^[24]; Two of Levi's⁶ siblings, Phebe and Jesse⁶, married members of the Waters family, as did Olive Noble's brother Charles who married Ann Waters. And do not forget the Kingsbury, NY tie between Levi⁶ and the Nobles above.

Process of Elimination

Using the process of elimination, Carol Laun of the Salmon Brook Historical Society, who has spent years studying the Holcombs of Connecticut, completed a paper^[25] on all the possible candidates for James⁷ father and came up with Levi⁶ as the most likely choice.

Conclusion

Though all the above evidence is circumstantial, by using close proximity, generational naming patterns, land records, collateral family interactions, family eliminations, and logic, this is the best evidence at this time (2015) to prove the relationship between Levi⁶ and his son James⁷. Hopefully this article will come into the hands of fellow researchers who have something more to add and/or correct concerning this branch of Holcombs. Thank you.

Looking at naming patterns, there are some possibilities. Levi had brothers named Ezra and Asa. He had a cousin named James (son of his uncle Ezekiel). Chloe is the name of his second wife, but she was born before he married a second time. William shows up in many of the Holcomb families. James named a son Levi and we don't know the names of many of his other children.

According to his pension, Levi served in the Revolutionary War as a substitute for his brother Enos and then as a substitute for his brother Ezra. Then he enlisted again on his own for 15 months. He was in PA on 4 Mar 1831 in Tioga Co. before he applied for his pension. By 4 Sept 1834, he was back in NY, in Steuben Co. Then in Fall 1845 he moved to WI with some of his children. Each time the pension payment source had to be changed. He was on the 1840 pension list in NY, age 74 (actually 77)

Who was his first wife? A woman from Granby or New York? Daughter Huldah said NY. Why did he come back to Granby to marry a second wife? How did he know Chloe Poisson? Maybe he was married to her sister and that is why he has a daughter named Chloe??? Unfortunately, we have no information about Chloe Poisson. Where was he in 1820?

More questions than answers.

The children listed in Levi's census records also raise some problems. Only 4 sons are in 1810, but if James was the oldest son, he may have already moved to Granville in 1807 as stated in the 1855 census. Then there could be 5 sons. But the daughters raise another problem. There are 3 daughters in 1790. In 1800 there is a 4th daughter. But in 1810, there are 6 females listed with Chloe, 3 of them 26-45, 1 was 16-26 and 2 were 10-16. There were no daughters under ten in 1800, so the 2 who were 10-16 cannot belong. That leaves 4 possible daughters, although some of the older girls should have been married by this time. Maybe there were only 9 children. I am leaving Cynthia out, because I can't find any connection for her.

We don't know where he was in 1820. 1830 has the wrong ages and no children. The children in 1840 must be a son and granddaughters. Chloe must have died between 1840 and 1850.

When did Ezra Sr. die? In his case, there are too many vital records, a rarity in this family. The Holcomb genealogy says he died in Granville in 1811. The First Church records in Granby have a date of 23 Apr 1813 and he would have been 78 years. The Granville, MA church records list the deaths of two Ezra Holcombs, one after 8 Dec 1809 (age 76 so born c.1733) and one after 23 Sept 1816. The date here has a strikeover and could be age 51, born 1765 or age 31, born 1785. The Granville Vital Records have Ezra dying of old age in 1809, age 76 and read the other Ezra as dying in 1816 age 81, born 1735.

The Granville VR for Ezra are taken from the church records, not gravestones, which did not have dates with the names and may not have been transcribed correctly. If we believe all these entries, at least three men named Ezra died within a few years. However, in that time period the only Ezra Holcombs in the area were Ezra and his son. The son moved to Granville, OH and died there. Ezra had his farm on both sides of the CT and MA boundary. I think he continued to attend the First Church in Granby. The death of his wife and his son Silas are in the First Church records. It is likely that the death of Ezra found in the First Church is correct. I can't explain either the 1811 genealogy date or the two dates in the Granville Church records. There are other examples of Granville Church records differing widely from gravestones and other records. It seems safe to assume the Granville Church may be inaccurate.

The marriage date of Ezra and Phebe is not known, but it must be around 1755. Their first child was born in 1756 and they joined the church the same year. Many researchers are led astray about this marriage date by a court case Ezra was involved in concerning a will Phebe's father, Nathaniel Gillet, signed 24 Apr 1773. Nathaniel signed everything to his son John for taking care of his parents until they died. In April 1781, Ezra Holcomb made a reciprocal agreement with John Gillet, assuming John's parental responsibilities and receiving the benefits. Nathaniel Gillet agreed to this change. In return, Ezra signed his farm in Granby and Granville over to John Gillet. Another Gillet son persuaded his father Nathaniel to sign another will so Ezra went to court. At one point he testified that he was married to Phebe Gillet **before** 24 Apr 1773, to prove he was part of the family long before the will was written. That does not mean he married Phebe in 1773, which many researchers assumed, causing all sorts of problems with the children born before that date. The Holcomb genealogy omits the word "before" but the original document was researched and the genealogy is wrong. Ezra won the case.

Ezra Holcomb and wife were members of the First Church 8 Aug 1756. Ezra served in the Revolutionary War. According to the Holcomb genealogy, Ezra lived in a gambrel roofed house on the west road in Granby before moving to Granville, MA. The west road is now Barn Door Hills Road and the gambrel roofed house at #31 is lived in by a Society member.

The birth order of Ezra's children is unknown and the dates found in the Holcomb genealogy are incomplete. The only dates with proof are Ezra Jr., Phebe, Levi and Asa. Alvin has a complete date of birth, but no documentary source.

Land Records

Ezra Holcomb lived in North Granby near the MA border. He lived on Granville Road or Rt. 189. He ended up owning a farm on both sides of the Colony line. He was always said to be "of the Wedge" which was a much disputed area of North Granby. Claimed at first by both MA and CT, it was kind of a "no man's land" where people could avoid paying taxes to both colonies.

I could not find where Ezra first acquired land in the Wedge, but he was selling some to his brother-in-law, Dr. Josiah Topping, in 1764. Next is the confusing deed mentioned under Reuben. In 1772, for only 50 pounds, Ezra's brother Reuben sold him 50 acres bordering on the Colony Line. The deed included his dwelling house and barn on the west side of Granville Road. However, there is no record of Reuben ever living in the Wedge. He seems to have always lived in West Granby. Ezra, his wife and children lived there for nine years.

In 1781, Ezra made a reciprocal arrangement with John Gillet, his wife's brother. John was named in his father Nathaniel's 1773 will to inherit everything for taking care of his parents until they died. Ezra agreed to take responsibility for their care and then receive the farm after their death. Nathaniel Gillet agreed to this arrangement. In return, Ezra signed over his farm on the Colony line to John Gillet. The farm consisted of 48 acres, dwelling house and barn in Granby, along with 60 acres across the line in Granville, MA.

Ezra received a share in his father David's estate in 1782, when David disposed of all of his property in Salmon Brook. The sons probably did not pay 400 pounds for this and their parents, no doubt, continued to live in the homestead. This may have just been a paper transaction to avoid creditors or paying any taxes when David died. Ezra sold part of his share to Dr. Topping. The money indicated on deeds was not always paid.

After his father, David, died in 1784, Ezra sold the rest of his inheritance to his son Ezra Jr. The same day, he also sold his son an additional 45 acres in North Granby. A few months later, Ezra Jr. sold part of the inheritance (the intervale land) to his uncle David. In 1785, Ezra Jr. sold his share in his grandfather's home lot to Pliny Hillyer. Ezra Jr. sold more of his grandfather's land in 1789, to his uncle Ezekiel.

There may have been more land transactions between Ezra and his sons, but if so, they are lost with the missing Granby land record books from the 1790s.

The 1800 census shows Ezra living next to sons Ezra Jr., Jesse and Asa. In 1806, Ezra, Jesse and Asa mortgaged "the south part of our farm" in Granby to Daniel Hays 3rd and Jonathan Barlow. On the same day, Ezra quitclaimed the rest of his Granby farm to his son Asa for a bond of \$1000. It included 70 acres and buildings.

The following year, 1807, Alvin, son of Ezra, mortgaged his land in Granville to his father for \$700. Ezra had tried to help at least four of his sons with land. Ezra Jr. received the land Ezra had inherited from his father David. Jesse was sharing the family homestead and Asa was given a large part of the homestand. Alvin was helped financially to buy land in Granville.

Ezra Sr. probably thought his children were all getting settled either in North Granby or Granville, MA. But it seems that the urge to move West was affecting these Holcombs. In 1809, Ezra Jr. was selling and buying land, perhaps in preparation for his departure.

1810 was a year of tremendous change for Ezra's children. Levi had been living in Washington Co. NY before 1790. Perhaps he encouraged his brothers to emigrate. As a moved to Fort Ann, Washington Co. NY in 1806 and Jesse was there by 1810. Ezra Jr. went to Granville, OH and the husband of his deceased daughter Phebe, Abner Waters, moved to Gustavus, OH with his 2nd wife.

Four of Ezra's eight children were gone. Phebe was dead, Enos probably never married according to his will and Silas would died, unmarried, burned to death, in 1821. The only son who stayed in the area and raised a large family, was Alvin. And even Alvin moved to NY after his wife died. He went to live with his son Alvin Jr. in Colesville, Broome Co. NY.

The grandchildren of David and Mehetible Holcomb are part of the Westward Movement.

Other records put him in other towns in Saratoga Co. He was a Revolutionary War pensioner and died in Edinburg in 1837. We don't know the names of any of his children, although a few possibilities have been found in census records. He did have a half brother named James.

In the pension records the town of Day in Saratoga Co. is also mentioned. Ezekiel is found in census records in Concord, Saratoga Co. NY. Day, Edinburg and Concord are all names for the same area as borders were changed and new towns formed.

The known children of James and Olive Noble Holcomb are in Washington Co. NY, which is not far from Saratoga Co., but there is no proof of any connection. Ezekiel 6 was probably James' cousin. Possible, but most likely No

8. James 7, Levi 6, Ezra 5, David 4, Nathaniel 3, 2, Thomas 1 Holcomb Census and land record research is leading to this probable family line for James Holcomb. All the early records for Levi are in Washington Co. NY. His children were born in Washington Co. Some of his children, including James, stayed in the area. Levi didn't move on until he was in his 50s or 60s when he moved with one or more of his children.

Much of the information found for Levi came from the internet. Some is accurately sourced and some is very questionable.

There are still many unanswered questions about both Levi and James. Who was Levi's first wife? Why did he come back to Granby to marry his second wife? What is Chloe Poisson's background? That is not a common Granby name. Nothing is known about her.

We don't really know how many children Levi had or all their names or birth order. The same is true of James' family. The Holcomb genealogy and the Gillet genealogy miss James and other relatives completely. And the Holcomb genealogy has many errors. The lack of vital records and church records is frustrating. A family Bible would be a treasure, if one exists.

So for Levi, a qualified Yes is the most likely answer.
